Rationale

To explain to our school community the Department's and Benton Junior College's policy requirements and expectations relating to students using mobile phones and other personal mobile devices during school hours.

This policy applies to all students at Benton Junior College whose personal mobile phones and other mobile devices that they bring onto school premises during school hours, including recess and lunchtime.

Aim

To ensure all students understand their responsibilities relating to the use of mobile phones and other personal mobile devices at school.

Implementation

Benton Junior College understands that students may bring a personal mobile phone to school, particularly if they are travelling independently to and from school.

A mobile phone is a telephone with access to a cellular (telecommunication) system, with or without a physical connection to a network. "For the purpose of this policy, "mobile phone" refers to mobile phones and any device that may connect to or have a similar functionality to a mobile phone such as smart watches."

At Benton Junior College:

- Students who choose to bring mobile phones to school must have them switched off and securely stored during school hours. Students are required to leave their mobile devices with their teacher on arrival at school and collect at 3.15pm dismissal. Teachers will store collected phones and devices in a secure box within their classrooms.
- Exceptions to this policy may be applied if certain conditions are met (see below for further information)
- When emergencies occur, parents or carers should reach their child by calling the school's office.

Personal mobile phone use

In accordance with the Department's [Mobile Phones — Student Use Policy](#) issued by the Minister for Education, personal mobile phones must not be used at Benton Junior College during school hours, including lunchtime and recess, unless an exception has been granted.

Where a student has been granted an exception, the student must use their mobile phone for the purpose for which the exception was granted, and in a safe, ethical and responsible manner.

Secure storage

Mobile phones/devices owned by students at Benton Junior College are considered valuable items and are brought to school at the owner's (student's or parent/carer's) risk. Students are encouraged not to bring a mobile phone to school unless there is a compelling reason to do so. Please note that Benton Junior College does not have accident insurance for accidental property damage or theft. Students and their parents/carers are encouraged to obtain appropriate insurance for valuable items. Refer to the Department's [Claims for Property Damage and Medical Expenses policy](#).]

Where students bring a mobile phone to school, Benton Junior College will provide secure storage. Secure storage is storage that cannot be readily accessed by those without permission to do so. At Benton Junior College students are required to store their phones, by handing them to their classroom teacher who will place them in the class's phone storage box. The box will be sent to and stored in the teacher's lockable filing cabinet.

Enforcement

Students who use their personal mobile phones inappropriately at Benton Junior College may be issued with consequences consistent with our school's existing student engagement policies; *Student Wellbeing and Engagement* and *Anti Bullying* policies.

At Benton Junior College inappropriate use of mobile phones is **any use during school hours**, unless an exception has been granted, and particularly the use of a mobile phone:

- in any way that disrupts the learning of others
- to send inappropriate, harassing or threatening messages or phone calls
- to engage in inappropriate social media use including cyber bullying
- to capture video or images of people, including students, teachers and members of the school community without their permission
- to capture video or images in the school toilets, changing rooms, swimming pools and gyms
- during exams and assessments

Exceptions

Exceptions to the policy:

- may be applied during school hours if certain conditions are met, specifically,
 - Health and wellbeing-related exceptions; and
 - Exceptions related to managing risk when students are offsite.
- can be granted by the Principal, or by the teacher for that class, in accordance with the Department's [Mobile Phones — Student Use Policy](#).

The three categories of exceptions allowed under the Department's [Mobile Phones — Student Use Policy](#) are:

1. Learning-related exceptions

2. Health and wellbeing-related exceptions

| Specific exception | Documentation |

3. Exceptions related to managing risk when students are offsite

| Specific exception | Documentation |

| When students are offsite (not on school grounds) and unsupervised with parental permission | Risk assessment planning documentation |

Where an exception is granted, the student can only use the mobile phone for the purpose for which it was granted.

Camps, excursions and extracurricular activities

Benton Junior College will provide students and their parents and carers with information about items that can or cannot be brought to camps, excursions, special activities and events, including personal mobile phones.

Exclusions

This policy does not apply to

- Out-of-school-hours events where parents are responsible for the supervision of their child
- Travelling to and from school

Communication

This policy will be communicated to our school community in the following ways:

- Available publicly on our school's website
- Included in staff induction processes and staff training
- Included in school newsletter
- Discussed at annual staff briefings/meetings
- Discussed at parent information nights/sessions
- Hard copy available from school administration upon request
